**410 PROBATION ORDER**

Conditions of Probation pursuant to Illinois Compiled Statutes Chapter 720, Section 570/410

On this Day, defendant herein, having admitted to the facts which form a basis for the offense of Unlawful possession of a controlled substance, in violation of 720 ILCS 570/402 (c), a Class 4 Felony, and the court being duly advised in the premises:

That the Court being of the opinion that neither a term of imprisonment nor of formal probation is appropriate, being that the defendant is a first offender as defined in Chapter 720, Sections 550/10 and 570/410.

It is Hereby Ordered that the defendant be admitted to a term of probation for 24 months and that as a condition of said probation, the defendant:

1. Shall not violate any criminal statute of any jurisdiction;
  2. Shall refrain from possessing a firearm or other dangerous weapon;
  3. Shall not possess or in any way use any controlled substance or cannabis;
  4. Shall refrain from having in his body the presence of any illicit drug prohibited by the Cannabis Act, or the Illinois Controlled Substances Act, unless prescribed by a physician, and submit samples of his blood or urine, or both, for tests to determine the presence of any illicit drug as requested by the Court or his probation officer, and waives the right of confrontation to contest the results.
  5. Shall notify the State's Attorney's Office and the Clerk of the Circuit Court of any change of address within 72 hours;
  6. Shall perform no less than 30 hours of community service;
  7. Shall appear at all future court dates set for this case;
  8. Shall pay: [X] court costs \$ \_\_\_\_\_; [X] drug assessment fee \$ 500.00; [X] crime lab fees \$ 100.00; [X] street value fine \$ \_\_\_\_\_; [X] drug related fine \$ 100.00;
  9. Shall [ ] obtain a drug & alcohol evaluation and comply with the recommendations therein;
  10. Shall be personally present before this Court for status hearing set \_\_\_\_\_.
  11. Shall serve \_\_\_\_\_ days in County jail, be given credit for \_\_\_\_\_ days already served in the Will County Detention Facility.

It is Further Ordered that this order is continued per the People of the State of Illinois verifying that this is, inact, the first offense by the defendant. If the Court determines that the offense covered by this order is not the first offense as defined in Chapter 720, Sections 550/10 or 570/410, then this Order shall be revoked and the defendant re-sentenced accordingly.

Judgment of Conviction Is Stayed and this case is continued \_\_\_\_\_, for termination of Section 410 probation and this Court retains jurisdiction over said defendant.
