**SCR 215 MEDICAL/MENTAL EXAMINATION ORDER AT REDUCED RATE**

Cause comes on for entry of an Order supplementing the separate Order entered this date regarding the SCR 215 Medical/Mental Examination; being fully advised in the premises, the Court HEREBY FINDS and IT IS HEREBY ORDERED:

1. The Court finds that the Plaintiff is indigent as defined in 735 ILCS 5/5-105(a)(2) and therefore the Plaintiff's fees and costs for the 215 Expert are \_\_\_\_% waived. Plaintiff shall pay \_\_\_\_% of the 215 Expert's fees and costs. This determination is subject to annual review or sooner as the Court may order upon a substantial change in Plaintiff's financial circumstances. The Clerk shall send a copy of the appointment Order and this Order to the Will County Assistant Trial Court Administrator.
2. The Court finds that the Defendant is indigent as defined in 735 ILCS 5/5-105(a)(2) and therefore the Defendant's fees and costs for the 215 Expert are \_\_\_\_% waived. Defendant shall pay \_\_\_\_% of the 215 Expert's fees and costs. This determination is subject to annual review or sooner as the Court may order upon a substantial change in Defendant's financial circumstances.

4. The SCR 215 Expert shall follow the direction of the Judge as set forth in the Order of appointment and in any Order modifying the same thereafter.
5. The 215 Expert must prepare and send a written report of the examination to the attorney for the party requesting the examination and the party examined within 21 days from completion of the examination. Additionally, the 215 Expert must file in the Court case for review and approval the

Expert's final bill. The final bill shall be sent to all parties of record within five (5) business days of issuance of the written report. Time is of the essence regarding the submission of the final bill. Failure to timely submit the written report and the final bill **shall** result in the automatic forfeiture of the Expert's right to seek payment for the evaluation and written report.

6. Hearing on the 215 Expert's fees shall be heard on the first date following issuance of the Report and final bill. Status on completion of the 215 Expert's evaluation and hearing on the 215 Expert's fees is set for \_\_\_\_\_, 20\_\_\_\_ at \_\_\_\_\_. Upon entry of Order approving fees, the Clerk shall send a copy of the Order to the Will County Assistant Trial Court Administrator who will process the Order for payment.
