PROBATION ORDER

Conditions of Probation pursuant to Illinois Compiled Statutes
Chapter 730, Section 5/5-6-3

On this day, defendant herein, having been convicted of the offense of _____

IT IS HEREBY ORDERED that the defendant be sentenced to a term of probation for _____ months and that
as a condition of said probation the defendant:

1. Shall not violate any criminal statute of any jurisdiction.
2. Shall report to and appear before the Will County Adult Probation Officer this date and at such other dates and times as directed by the Officer.
3. Shall refrain from possessing a firearm or other dangerous weapon.
4. Shall not leave the State without the consent of the court, or in circumstances in which the reason for the absence is of such emergency nature that prior consent by the Court is not possible, with the prior notification and approval of the Probation Officer.
5. Shall permit the Probation Officer to visit at the defendant's home or elsewhere to the extent necessary to discharge the Probation Officer's duties.
6. Shall notify the Probation Department and the clerk of the Circuit Court of any change of address within seventy-two (72) hours.
7. Shall refrain from having in his body the presence of any illicit drug prohibited by the Cannabis control Act, or the Illinois Controlled Substances Act, unless prescribed by a physician, and submit samples of his blood and urine, or both, for tests to determine the presence of any illicit drug and requested by his Probation Officer or the Court.
8. Shall pay: (X) court costs \$ _____ ; () Probation fee \$ _____ ; () Restitution \$ _____.
9. Shall be personally present before this Court on future dates set therein.
10. Defendant's bond to apply to payment in the amount of \$ _____ ; balance now due \$ _____.
11. Compliance within six (6) months of the entry of this Order.
12. Shall serve _____ jail time in the Will County ADF; credited for _____ jail time already served.
13. Counseling as deemed appropriate by the Probation Officer.

IT IS FURTHER ORDERED that the Probation Department report immediately to this Court any violation by said defendant of any aforementioned condition of probation and that said probation may be revoked by this Court in its discretion upon violation of same.
