ORDER FOR ELECTRONIC MONITORING

In addition to all other conditions of bail, **which remain in full force and effect**, the Defendant is Ordered as a further condition of bail to be placed on electronic monitoring for the following period: _____.

In addition, the Defendant is Ordered to comply with the following conditions:

- GPS Monitoring as a condition of the Pre-Trial Release Program.
- Home Confinement Monitoring as a condition of the Pre-Trial Release Program and shall abide by the following curfew: _____
- Defendant will refrain from entering within three-thousand (3,000) feet of the exclusion zones et forth below:

- BACTrack alcohol monitoring (Requires iOS or Android Smartphone)
- No contact in person, by phone, by mail, by email, by social media or by any other means with:

- Defendant shall pay to Clerk of the Circuit Court all fees associated with Electronic Monitoring as set forth below as well as for loss of or damage to the Electronic Monitoring device while it is in the Defendant's possession. Any failure to do so will result in notification to the Court and a judgement being entered against the Defendant for the amount owed.
 - Defendant is hereby Ordered to pay \$ _____ by the fifteenth of this month and \$97.50 every two weeks thereafter on the fifteenth and the last day of the month.
 - Defendant is hereby Ordered to pay \$ _____ by the thirtieth of this month and \$97.50 every two weeks thereafter on the fifteenth and the last day of the month.
- The Court, having found that the Defendant is unable to pay electronic monitoring fees, hereby Orders the fees to be paid by the Will County Circuit Court. However, the Defendant is still required to promptly pay for all costs associated with loss or damage to the Electronic Monitoring device while it is in the Defendant's possession.

In addition, the Defendant shall fully comply with all terms and conditions of the Electronic Monitoring Program as set forth in the Client's Electronic Monitoring Agreement and all instructions from Will County and Will County Pre-Trial/Court Services personnel. Failure to comply will lead to notification to the Court.

Defendant, with counsel, hereby stipulates to the validity of the technology used in the Electronic Monitoring device, and agrees to waive the right to a *Frye* Hearing or other court hearing regarding these issues, should a violation occur. Defendant hereby agrees to the foundation and admissibility of the violation report as a business record.
