Conditions of Probation pursuant to Illinois Compiled Statutes
Chapter 730, Section 5/5-6-3.6

1. Shall not violate any criminal statute of any jurisdiction.
2. Shall report to and appear before the Will County Adult Probation Officer this date and at such other dates and times as directed by the Officer.
3. Shall refrain from possessing a firearm or other dangerous weapon.
4. Attend and participate in any Program activities deemed required by the Probation Officer or Court.
5. Maintain employment or attempt to obtain employment.
6. Attend educational courses/program(s) designed to obtain a high school diploma or high school equivalency, or work toward completing a vocational training program.
7. Shall refrain from having in his body the presence of any illicit drug prohibited by Methamphetamine Control and Community Protection Act or the Illinois Controlled Substances Act, unless prescribed by a physician, and submit samples of his blood and urine, or both, for tests to determine the presence of any illicit drug and requested by the Probation Officer or the Court.
8. Perform _____ hours of Community Service at the direction of the Will County Probation Department.

10. Shall be personally present before this Court on future dates set therein.
11. Counseling or program participation as deemed appropriate by the Probation Officer.
